Definitions of "Tithe" as a noun

According to the [Oxford Dictionary of English](#), “tithe” as a noun can have the following definitions:

- *An offering of a tenth part of some personal income.*
- *One tenth of annual produce or earnings, formerly taken as a tax for the support of the Church and clergy.*
- *A tenth of a specified thing.*
- *A levy of one tenth of something.*
- *(in certain religious denominations) a tenth of an individual's income pledged to the Church.*



Synonyms of "Tithe" as a noun (11 Words)

- assessment** An amount determined as payable.
*The **assessment** of educational needs.*
- charge** The price charged for some article or service.
*I get a real **charge** out of working hard.*
- contribution** A voluntary gift (as of money or service or ideas) made to some worthwhile cause.
*I am proud of my **contribution** in advancing the project.*
- duty** Work that you are obliged to perform for moral or legal reasons.
*A strong sense of **duty**.*
- excise** A tax levied on certain goods and commodities produced or sold within a country and on licences granted for certain activities.
*The rate of **excise** duty on spirits.*
- fee** A fixed charge for a privilege or for professional services.
*Tuition **fees** have now reached 9000 a year.*
- impost** Money collected under a tariff.
*Some of the labels are used for the purpose of collecting Customs duty or other **imposts**.*

levy	An act of levying a tax fee or fine. <i>Edward I and Edward II had made substantial use of the feudal levy for raising an army.</i>
tariff	A list of import or export tariffs. <i>The reduction of trade barriers and import tariffs.</i>
toll	A fee levied for the use of roads or bridges (used for maintenance). <i>Motorway tolls.</i>
tribute	A proportion of ore or its equivalent, paid to a miner for his work, or to the owner or lessor of a mine. <i>A tribute show.</i>

Usage Examples of "Tithe" as a noun

- *He hadn't said a tithe of the prayers he knew.*

Associations of "Tithe" (30 Words)

account	The department of a company that deals with financial accounts. <i>She turned her writing skills to good account.</i>
annuitant	A person who receives an annuity.
bill	A poster or handbill. <i>He pulled down the bill of his cap and trudged ahead.</i>
buyer	A person who makes a purchase.
cheque	An order to a bank to pay a stated sum from the drawer's account, written on a specially printed form. <i>Fees are payable by cheque or postal order.</i>
compensation	The action or process of awarding compensation. <i>The grey streets of London were small compensation for the loss of her beloved Africa.</i>
cost	The effort, loss, or sacrifice necessary to achieve or obtain something. <i>The tunnel has been built at no cost to the state.</i>
customs	The duties levied by a government on imported goods. <i>From 1374 Chaucer worked as controller of customs on wool in the port of London.</i>
debit	Enter as debit. <i>Cash terminals automatically debit a customer's bank account.</i>
deductible	Able to be deducted, especially from taxable income or tax to be paid. <i>Childcare vouchers will be deductible expenses for employers.</i>

due	A payment that is due e.g. as the price of membership. <i>We'll head due south again on the same road.</i>
emolument	Compensation received by virtue of holding an office or having employment (usually in the form of wages or fees). <i>A clause in the U.S. constitution prevents sitting legislators from receiving emoluments from their own votes.</i>
<u>expenditure</u>	The act of consuming something. <i>Work is the expenditure of energy.</i>
fee	A fixed charge for a privilege or for professional services. <i>Fee the steward.</i>
levy	A tax raised by levying. <i>There were no goods to levy upon.</i>
offering	The verbal act of offering. <i>Offerings during Lent will always be gratefully received.</i>
overpayment	Payment in excess of what is due. <i>A refund for overpayment of tax.</i>
pay	Suffer a misfortune as a consequence of an action. <i>Jobs that pay 5 an hour.</i>
payable	Debts owed by a business; liabilities. <i>A check payable to John Doe.</i>
rates	A local tax on property (usually used in the plural).
receivable	Able to be received. <i>Accounts receivable.</i>
<u>salary</u>	Pay a salary to. <i>A 15 per cent salary increase.</i>
sale	The activity or business of selling products. <i>Director of sales and marketing.</i>
surcharge	Mark a postage stamp with a surcharge. <i>The air raids had surcharged the emergency wards.</i>
tariff	Fix the price of something according to a tariff. <i>These services are tariffed by volume.</i>
<u>tax</u>	Levy a tax on. <i>The income will be taxed at the top rate.</i>
taxable	Liable to be taxed; subject to tax. <i>Taxable employee benefits.</i>
taxation	Government income due to taxation. <i>Direct taxation was low.</i>

vat	Place or treat in a vat. <i>The grapes are vatted for between 15 and 21 days and then aged in small barrels.</i>
wage	The part of total production that is the return to labour as earned income as distinct from the remuneration received by capital as unearned income. <i>We were struggling to get better wages.</i>
