- *The position of being the champion of a major sports competition.*
- *A word such as Mrs or Dr that is used before someone's name to indicate their profession or marital status.*
- *A descriptive or distinctive name that is earned or chosen.*
- *Written material introduced into a movie or TV show to give credits or represent dialogue or explain an action.*

- *The name of a book, composition, or other artistic work.*
- *A book, magazine, or newspaper considered as a publication.*
- *A name that describes someone's position or job.*
- *An established or recognized right.*
- *The status of being a champion.*
- *A caption or credit in a film or broadcast.*
- *An appellation signifying nobility.*
- *A parish church in Rome under a cardinal.*
- *An informal right to something.*
- *A legal document signed and sealed and delivered to effect a transfer of property and to show the legal right to possess it.*
- *The name of a work of art or literary composition etc.*
- *(usually plural) written material introduced into a movie or TV show to give credits or represent dialogue or explain an action.*
- *A heading that names a statute or legislative bill; may give a brief summary of the matters it deals with.*

- *An identifying appellation signifying status or function: e.g. `Mr.' or `General.*

- *A right or claim to the ownership of property or to a rank or throne.*
- *A word such as Lord or Dame that is used before someone's name, or a form that is used instead of someone's name, to indicate high social or official rank.*

deed	<p>A legal document that is signed and delivered, especially one regarding the ownership of property or legal rights. <i>Doing good deeds.</i></p>
deed of conveyance	<p>A legal document signed and sealed and delivered to effect a transfer of property and to show the legal right to possess it.</p>
<u>denomination</u>	<p>The face value of a banknote, coin, or postage stamp. <i>The Presbyterian community is the second largest denomination in the country.</i></p>
<u>designation</u>	<p>The action of choosing a place for a special purpose or giving it a special status. <i>Dibden Bay s designation as a Site of Special Scientific Interest.</i></p>
device	<p>A form of words intended to produce a particular effect in speech or a literary work. <i>Works of strange device.</i></p>
first place	<p>The time at which something is supposed to begin.</p>
form of address	<p>An arrangement of the elements in a composition or discourse.</p>
head	<p>A headache especially one resulting from intoxication. <i>It is easy to get up a head of pheasants with the aid of good keepers.</i></p>

heading	A strip of cloth at the top of a curtain above the hooks or wire by which it is suspended. <i>Chapter headings.</i>
inscription	A short message (as in a book or musical work or on a photograph) dedicating it to someone or something. <i>The inscription of memorable utterances on durable materials.</i>
label	A radioactive isotope that is used in a compound in order to trace the mechanism of a chemical reaction. <i>The label salsa seems especially meaningless when applied to musicians like Tito Puente.</i>
legend	Brief description accompanying an illustration. <i>A picture of a tiger with the legend Go ahead make my day.</i>
medal	A metal disc typically of the size of a large coin and bearing an inscription or design, made to commemorate an event or awarded as a distinction to someone such as a soldier or athlete.
motto	A short sentence or phrase chosen as encapsulating the beliefs or ideals of an individual, family, or institution. <i>The family motto is Faithful though Unfortunate.</i>
<u>name</u>	A person's reputation. <i>Those are two names for the same thing.</i>
<u>nickname</u>	A descriptive name for a place or thing. <i>Mallender's fair complexion gave rise to his nickname Ghost.</i>
offering	The verbal act of offering. <i>Offerings during Lent will always be gratefully received.</i>
office	A service conducted daily as part of the office. <i>A patient walks in to a doctor's office.</i>
ownership of	The relation of an owner to the thing possessed; possession with the right to transfer possession to others.
<u>plate</u>	Any flat platelike body structure or part. <i>She lifted the plate in victory.</i>
position	A proposition laid down or asserted a tenet or assertion. <i>The company's financial position is grim.</i>
prize	Something given for victory or superiority in a contest or competition or for winning a lottery. <i>The sloop had been taken as a prize.</i>
proprietary rights to	An unincorporated business owned by a single person who is responsible for its liabilities and entitled to its profits.

<u>publication</u>	A copy of a printed work offered for distribution. <i>The publication of April trade figures.</i>
rank	High social position. <i>An army officer of high rank.</i>
right to	The interest possessed by law or custom in some intangible thing.
rubric	A direction in a liturgical book as to how a church service should be conducted. <i>Party policies on matters falling under the rubric of law and order.</i>
<u>shield</u>	A stylized representation of a shield used for displaying a coat of arms. <i>A face shield is sometimes an integral part of a safety helmet.</i>
slogan	A motto associated with a political party or movement or other group. <i>Students were chanting slogans.</i>
sobriquet	A familiar name for a person (often a shortened version of a person's given name). <i>She was a vast and haughty person who answered to the sobriquet Duchesse.</i>
status	The official classification given to a person, country, or organization, determining their rights or responsibilities. <i>He had the status of a minor.</i>
statute title	An act passed by a legislative body.
subheading	A heading of a subdivision of a text. <i>This project falls under the subheading of Skills and the Workforce.</i>
subtitle	Captions displayed at the bottom of a cinema or television screen that translate or transcribe the dialogue or narrative. <i>Films in foreign languages with English subtitles.</i>
<u>tag</u>	A small piece or part that is attached to a main body. <i>His writing is full of tags from the Bible and Shakespeare.</i>
title of respect	An informal right to something.
<u>trophy</u>	An award for success in war or hunting.
wording	The words used to express something; the way in which something is expressed. <i>The standard form of wording for a consent letter.</i>

adopt	Choose (someone) as a candidate for office. <i>They adopted two children from Nicaragua.</i>
affectionate	Expressing fondness. <i>An affectionate kiss.</i>
alias	As known or named at another time or place. <i>A spy operating under the alias Barsad.</i>
alphabetically	In alphabetical order. <i>Books are now arranged alphabetically by author.</i>
appellation	Identifying word or words by which someone or something is called and classified or distinguished from others. <i>The city fully justifies its appellation the Pearl of the Orient.</i>
appraisal	An expert estimation of the quality, quantity, and other characteristics of someone or something. <i>The report has been subject to appraisal.</i>
assessment	The classification of someone or something with respect to its worth. <i>The assessment for repairs outraged the club's membership.</i>
autograph	Written in the author's own handwriting. <i>A songbook in Purcell's autograph.</i>
caption	Provide with a caption as of a photograph or a drawing. <i>The programme has a closing caption thanking the university for its cooperation.</i>
cognomen	A name or nickname.
descendants	All of the offspring of a given progenitor.
dub	The new sounds added by dubbing. <i>Prewaxed thread has dramatically eased the process of dubbing.</i>
epithet	An epithet used as a term of abuse. <i>People jeered and hurled racial epithets.</i>
evaluation	Act of ascertaining or fixing the value or worth of. <i>An initial evaluation of the programme.</i>
given	(usually followed by `to') naturally disposed toward. <i>She was not often given to anger.</i>
heading	A strip of cloth at the top of a curtain above the hooks or wire by which it is suspended. <i>The heading seemed to have little to do with the text.</i>

judgment	(law) the determination by a court of competent jurisdiction on matters submitted to it. <i>He was reluctant to make his judgment known.</i>
<u>moniker</u>	A familiar name for a person (often a shortened version of a person's given name). <i>His real moniker is Dave Kennedy.</i>
<u>name</u>	Identify correctly by name. <i>The club have asked United to name their price for the striker.</i>
<u>nickname</u>	Give a nickname to. <i>Henry's nickname was Slim.</i>
nominally	In name only. <i>The Republicans nominally controlled both houses of Congress but by slim margins.</i>
patronymic	A family name derived from name of your father or a paternal ancestor (especially with an affix (such as -son in English or O' - in Irish) added to the name of your father or a paternal ancestor). <i>A patronymic derived from the name of their original lordship.</i>
reputation	The general estimation that the public has for a person. <i>His reputation was tarnished by allegations of bribery.</i>
repute	Be generally regarded to be or as being (but not definitely the case). <i>The waters of the fountain are reputed to have healing properties.</i>
rubric	A heading on a document. <i>Art for a purpose not for its own sake was his rubric.</i>
<u>sir</u>	Used as a polite or respectful way of addressing a man, especially one in a position of authority. <i>Excuse me sir.</i>
sobriquet	A familiar name for a person (often a shortened version of a person's given name). <i>She was a vast and haughty person who answered to the sobriquet Duchesse.</i>
stature	High level of respect gained by impressive development or achievement. <i>A man of short stature.</i>
surname	Give a surname to. <i>Eddie Penham so aptly surnamed had produced a hand painted sign for us.</i>
