Associations of "To no avail meaning" (30 Words)

abnegation	The denial and rejection of a doctrine or belief. <i>Abnegation of the Holy Trinity.</i>
apophasis	Mentioning something by saying it will not be mentioned.
controvert	Deny the truth of (something). <i>Subsequent work from the same laboratory controverted these results.</i>
deniable	Able to be denied. <i>The government did agree to play a limited and deniable role in the rebellion.</i>
denial	A defendant’s answer or plea denying the truth of the charges against him. <i>The denial of insurance to people with certain medical conditions.</i>
deny	Deny oneself something restrain especially from indulging in some pleasure. <i>There was no way that I was going to deny myself ice cream.</i>
disallow	Refuse to declare valid. <i>He was offside and the goal was disallowed.</i>
disavow	Refuse to acknowledge; disclaim knowledge of; responsibility for, or association with. <i>The union leaders resisted pressure to disavow picket line violence.</i>
disavowal	The denial of any responsibility or support for something; repudiation. <i>They know this despite their disavowals.</i>
disclaim	Make a disclaimer about. <i>The earl disclaimed his title.</i>
extradite	Hand over (a person accused or convicted of a crime) to the jurisdiction of the foreign state in which the crime was committed. <i>Brazil refused to extradite him to Britain.</i>
gainsay	Deny or contradict (a fact or statement). <i>None could gainsay her.</i>

impugn	Dispute the truth, validity, or honesty of (a statement or motive); call into question. <i>The father does not impugn her capacity as a good mother.</i>
inadmissible	Not to be allowed or tolerated. <i>An inadmissible interference in the affairs of the Church.</i>
interdict	A court order forbidding an act; a negative injunction. <i>Army efforts to interdict enemy supply shipments.</i>
negate	Make ineffective; nullify. <i>Alcohol negates the effects of the drug.</i>
nullify	Make of no use or value; cancel out. <i>Judges were unwilling to nullify government decisions.</i>
objection	The speech act of objecting. <i>They have raised no objections to the latest plans.</i>
ostracism	The state of being banished or ostracized (excluded from society by general consent). <i>The family suffered social ostracism.</i>
perjure	Knowingly tell an untruth in a legal court and render oneself guilty of perjury. <i>She admitted that she had perjured herself.</i>
rebut	Drive back or repel (a person or attack). <i>But he their sharp assault right boldly did rebut.</i>
refusal	The act of refusing. <i>He became tired of his friend s refusal to see him.</i>
refuse	Refuse to let have. <i>Her horse refused a high hedge.</i>
refutable	Able to be refuted.
refutation	The speech act of answering an attack on your assertions. <i>His refutation of the charges was short and persuasive.</i>
refute	Prove that (someone) is wrong. <i>These claims have not been convincingly refuted.</i>
reject	Reject with contempt. <i>Some of the team s rejects have gone on to prove themselves in championships.</i>
rejection	The dismissing or refusing of a proposal, idea, etc. <i>The rejection of the application for parole.</i>
repudiate	Refuse to accept; reject. <i>She repudiated the accusations.</i>

repudiation Refusal to fulfil or discharge an agreement, obligation, or debt.
*Congressional **repudiation** of the treaty that the President had negotiated.*
