## The Forms of Trial

Infinitive	<b>to trial</b>
Present Tense	<b>trial / trials</b>
Past Tense	<b>commonwealth trialled, us trialed</b>
Present Participle	<b>commonwealth trialling, us trialing</b>
Past Participle	<b>commonwealth trialled, us trialed</b>

## Conjugate Trial

### Trial in Present Simple (Indefinite) Tense

<b>Singular</b>	<b>Plural</b>
<b>I trial</b>	<b>We trial</b>
<b>You trial</b>	<b>You trial</b>
<b>He/She/It trials</b>	<b>They trial</b>

## **Trial in Present Continuous (Progressive) Tense**

<b>Singular</b>	<b>Plural</b>
<b>I am commonwealth trialling, us trialing</b>	<b>We are commonwealth trialling, us trialing</b>
<b>You are commonwealth trialling, us trialing</b>	<b>You are commonwealth trialling, us trialing</b>
<b>He/She/It is commonwealth trialling, us trialing</b>	<b>They are commonwealth trialling, us trialing</b>

## **Trial in Present Perfect Tense**

<b>Singular</b>	<b>Plural</b>
<b>I have commonwealth trialled, us trialed</b>	<b>We have commonwealth trialled, us trialed</b>
<b>You have commonwealth trialled, us trialed</b>	<b>You have commonwealth trialled, us trialed</b>
<b>He/She/It has commonwealth trialled, us trialed</b>	<b>They have commonwealth trialled, us trialed</b>

## **Trial in Present Perfect Continuous Tense**

<b>Singular</b>	<b>Plural</b>
<b>I have been commonwealth trialling, us trialing</b>	<b>We have been commonwealth trialling, us trialing</b>
<b>You have been commonwealth trialling, us trialing</b>	<b>You have been commonwealth trialling, us trialing</b>
<b>He/She/It has been commonwealth trialling, us trialing</b>	<b>They have been commonwealth trialling, us trialing</b>

## **Trial in Past Simple (Indefinite) Tense**

### **Singular**

**I commonwealth trialled, us trialed**

**You commonwealth trialled, us trialed**

**He/She/It commonwealth trialled, us trialed**

### **Plural**

**We commonwealth trialled, us trialed**

**You commonwealth trialled, us trialed**

**They commonwealth trialled, us trialed**

## **Trial in Past Continuous (Progressive) Tense**

### **Singular**

**I was commonwealth trialling, us trialing**

**You were commonwealth trialling, us trialing**

**He/She/It was commonwealth trialling, us trialing**

### **Plural**

**We were commonwealth trialling, us trialing**

**You were commonwealth trialling, us trialing**

**They were commonwealth trialling, us trialing**

## **Trial in Past Perfect Tense**

### **Singular**

**I had commonwealth trialled, us trialed**

**You had commonwealth trialled, us trialed**

**He/She/It had commonwealth trialled, us trialed**

### **Plural**

**We had commonwealth trialled, us trialed**

**You had commonwealth trialled, us trialed**

**They had commonwealth trialled, us trialed**

## **Trial in Past Perfect Continuous Tense**

### **Singular**

**I had been commonwealth trialling, us trialing**

**You had been commonwealth trialling, us trialing**

**He/She/It had been commonwealth trialling, us trialing**

### **Plural**

**We had been commonwealth trialling, us trialing**

**You had been commonwealth trialling, us trialing**

**They had been commonwealth trialling, us trialing**

## **Trial in Future Simple (Indefinite) Tense**

### **Singular**

### **Plural**

**I will trial**

**We will trial**

**You will trial**

**You will trial**

**He/She/It will trial**

**They will trial**

## **Trial in Future Continuous (Progressive) Tense**

### **Singular**

### **Plural**

**I will be commonwealth trialling, us trialing**

**We will be commonwealth trialling, us trialing**

**You will be commonwealth trialling, us trialing**

**You will be commonwealth trialling, us trialing**

**He/She/It will be commonwealth trialling, us trialing**

**They will be commonwealth trialling, us trialing**

### **Singular**

### **Plural**

**I will have commonwealth trialed, us trialed**

**We will have commonwealth trialed, us trialed**

**You will have commonwealth trialed, us trialed**

**You will have commonwealth trialed, us trialed**

**He/She/It will have commonwealth trialed, us trialed**

**They will have commonwealth trialed, us trialed**
