- *A final demand or statement of terms, the rejection of which will result in retaliation or a breakdown in relations.*
- *A final peremptory demand.*



Synonyms of "Ultimatum" as a noun (18 Words)

command	The power or authority to command. <i>He obeyed her commands without question.</i>
<u>decree</u>	The issuing of a decree. <i>The decree guaranteed freedom of assembly.</i>
demand	The act of demanding. <i>There were many demands on his time.</i>
<u>dictum</u>	A short statement that expresses a general truth or principle. <i>The old dictum might be right.</i>
direction	Something that provides direction or advice as to a decision or course of action. <i>The campaign's lack of direction.</i>
<u>directive</u>	An official or authoritative instruction. <i>A new EC directive.</i>

edict	A formal or authoritative proclamation. <i>Clovis issued an edict protecting Church property.</i>
exhortation	An address or communication emphatically urging someone to do something. <i>No amount of exhortation had any effect.</i>
injunction	A judicial remedy issued in order to prohibit a party from doing or continuing to do a certain activity. <i>Injunction were formerly obtained by writ but now by a judicial order.</i>
instruction	Teaching; education. <i>He issued instructions to the sheriff.</i>
mandate	A document giving an official instruction or command. <i>A mandate to seek the release of political prisoners.</i>
order	The insignia worn by members of an order of honour or merit. <i>I gave the waiter my order.</i>
ordinance	A statute enacted by a city government. <i>His strict observance of religious ordinances was no doubt quickened by the remorse he felt.</i>
pronouncement	An authoritative declaration. <i>Distrust of the pronouncements of politicians was endemic.</i>
requirement	Required activity. <i>Choose the type of window that suits your requirements best.</i>
rule	A rule describing or prescribing a linguistic practice. <i>The rules of cricket.</i>
ruling	The reason for a court's judgment (as opposed to the decision itself). <i>The ruling was reversed in the appeal court.</i>
<u>stipulation</u>	A condition or requirement that is specified or demanded as part of an agreement. <i>A stipulation of fact was made in order to avoid delay.</i>



Usage Examples of "Ultimatum" as a noun

- *Their employers issued an ultimatum demanding an immediate return to work.*



Associations of "Ultimatum" (30 Words)

coda	The closing section of a musical composition. <i>The first movement ends with a fortissimo coda.</i>
completion	(American football) a successful forward pass in football. <i>The risk stays with the seller until completion.</i>
<u>conclude</u>	Say in conclusion. <i>They conclude their study with these words.</i>
conclusion	A proposition that is reached from given premises. <i>He drew his conclusions quickly.</i>
culmination	The decisive moment in a novel or play. <i>Their achievements stand as a culmination of centuries of development.</i>
deadline	The point in time at which something must be completed. <i>The deadline of 6pm passed without incident.</i>

<u>decease</u>	Pass from physical life and lose all bodily attributes and functions necessary to sustain life. <i>He deceased at his palace of Croydon.</i>
deciding	Having the power or quality of deciding. <i>Cast the deciding vote.</i>
<u>demise</u>	The time when something ends. <i>The demised property.</i>
<u>destination</u>	Denoting a place that people will make a special trip to visit. <i>He was nearly exhausted as their destination came into view.</i>
done	No longer happening or existing. <i>The turkey will be done to a turn.</i>
<u>dying</u>	Gradually ceasing to exist or function; in decline and about to disappear. <i>The dying embers of the fire.</i>
ending	The end of a word a suffix or inflectional ending or final morpheme. <i>The ending of the Cold War.</i>
epilogue	A short speech (often in verse) addressed directly to the audience by an actor at the end of a play. <i>The meaning of the book's title is revealed in the epilogue.</i>
<u>eventual</u>	Expected to follow in the indefinite future from causes already operating. <i>It's impossible to predict the eventual outcome of the competition.</i>
expiration	The end of a period of time. <i>At the end of expiration there is still a slight inflation in the lungs.</i>
expiry	The end of the period for which something is valid. <i>The expiry of the patent.</i>
<u>final</u>	The final approach of an aircraft to the runway it will be landing on. <i>The final cost will easily run into six figures.</i>
finale	The temporal end; the concluding time. <i>The festival ends with a grand finale.</i>
finis	The temporal end; the concluding time. <i>The market was up at the finish.</i>
finishing	The act of finishing. <i>The speaker's finishing was greeted with applause.</i>
last	The last position or finisher in a race or competition. <i>He was the last to leave.</i>
<u>latter</u>	Occurring or situated nearer to the end of something than to the beginning. <i>The President appoints the Prime Minister and on the latter's advice the rest of the government.</i>

notice	Notice or perceive. <i>She had good notices in her first film.</i>
passing	In sport the action of passing a ball to another team member. <i>The passing of the Cold War.</i>
perish	Be suffering from extreme cold. <i>An abandoned tyre whose rubber had perished.</i>
peroration	A flowery and highly rhetorical oration. <i>He again invoked the theme in an emotional peroration.</i>
surrender	The action of surrendering to an opponent or powerful influence. <i>The UK is opposed to surrendering its monetary sovereignty.</i>
termination	An ending or result of a specified kind. <i>A good result and a happy termination.</i>
windup	Operated by a mechanism. <i>Windup toys.</i>
